## **Evolving relationship between India and Palestine**

- In 1974, India became the first Non-Arab State to recognize Palestine Liberation Organization (PLO) as the sole and legitimate representative of the Palestinian people.

- Unlike in Israel, India does not have an embassy in Palestine.
- India voted in favour of Palestine for its acceptance as a full member of UNESCO.
- India co-sponsored the resolution that made Palestine a 'non-memberstate' of United Nations **General Assembly.**
- India supported the installation of the Palestine flag at UN premises.

## 2. India ranks 111 out of 125 countries in hunger index - The Hindu

**Relevance:** Important International institutions, agencies and fora-their structure, mandate. News:

India ranks 111 out of a total of 125 countries in the Global | Prelims Takeaway Hunger Index (GHI) 2023.

Global Hunger Index (GHI)

The Union government, though, contested India's performance for the third year in a row, citing flawed methodology.

### **Key Points**

- The index is jointly released by Concern Worldwide and Welthungerhilfe every October.
- Afghanistan, Haiti and 12 sub-Saharan countries perform worse than India on the GHI.
- The GHI score is based on a formula which combines four indicators that together capture the multi-dimensional nature of hunger including
  - Under-nourishment
  - child stunting
  - child wasting
  - child mortality.
- While India made significant strides between 2000 and 2015, with its score improving from 38.4 in 2000 to 35.5 in 2008 and 29.2 in 2015, over the past eight years
- Globally, the share of people who are undernourished, which is one of the indicators used in the index, actually rose from 7.5% in 2017 to 9.2% in 2022
- South Asia and Africa South of the Sahara are the world regions with the highest hunger levels, with GHI scores of 27.0 each, indicating serious hunger.
- West Asia and North Africa is the region with the third-highest hunger level with a score of 11.9 indicating "moderate" hunger level.
- Latin American and the Caribbean is the only region in the world whose GHI scores have worsened between 2015 and 2023.
- East and Southeast Asia, dominated by populous China, has the second-lowest 2023 GHI score of any region in the report.
- China, for example, is among the top 20 countries that each have a GHI score of less than 5.









### Reason:

- According to the GHI 2023 report, the stagnation in the fight against global hunger is largely due "to the combined effects of overlapping crises, including:
  - o the COVID-19 pandemic
  - o the Russia-Ukraine war
  - o economic stagnation
  - o the impacts of climate change
  - The intractable conflicts facing many countries of the world
- It adds that the combination of these crises have led to a cost of living crisis and exhausted the coping capacity of many countries.

The anti-defection law

#### The anti-defection law

- it was introduced in 1985, through the **52nd Amendment Act of 1985**.
- It was i**nserted in the Tenth Schedule** of the Indian Constitution and is popularly known as Anti Defection Act.
- Defection has been defined as a "conscious abandonment of allegiance or duty".
- It lays down the process of disqualification on grounds of defection.
- The presiding officer has the authority to disqualify a member on proven grounds of defection.
- The goal was to prevent the legislators from changing their political affiliations during their tenure in office.
- It applies to both the Parliament and the state assemblies.

#### Ground

- One of the most important grounds is the phrase "Voluntarily giving up his membership".
- It has a wider connotation than resignation.
- In **absence of formal resignation**, the giving up of his membership can also be inferred from the legislator's conduct.
- Another ground of Defection is "Violation of Instructions".
  - o It means that if the legislator votes or abstains from voting in the House contrary to a direction issued by the political party he belongs to, he is deemed to be disqualified.

# 7. Tea industry in 'acute financial crisis', says Indian Tea Association in a report - The Hindu

**Relevance:** Major crops-cropping patterns in various parts of the country, – different types of irrigation and irrigation systems storage, transport and marketing of agricultural produce and issues and related constraints; e-technology in the aid of farmers.

#### News:

• The Indian Tea Association (ITA), a leading body of tea planters, has recently showcased its concern over the industry's current financial distress as prices are not at par with the rising cost of production.

## **Current Status of the Industry:**

• As per the **status paper 'Tea scenario 2023' of ITA**, **tea prices rose at** a CAGR of **about 4% over the last decade**, but the **cost of vital inputs** grew at a CAGR of **9-15%** during the same period.

#### **Reasons for the Distress**

- **Surplus tea:** Besides, the **exponential increase in production** following the emergence of small tea growers resulted in surplus teas remaining in the system.
- Iran exports drop: Payment issues resulted in grim export to Iran, which constitutes almost 20% of total tea exports from India.

## Way Ahead:

• To mitigate the situation, the industry urged the government to consider **enhancing RoDTEP** (remission of duties or taxes on export products) incentive cap for high quality CTC, orthodox and Darjeeling teas.

# 1. Gaza war and markets: No impact for now, but need for caution - Indian Express

**Relevance:** Effect of policies and politics of developed and developing countries on India's interests, Indian diaspora.

#### Context:

- Conflict between Israel and Hamas in West Asia **initially led to uncertainty in the markets**, witnessing a **sharp sell-off and investors opting for safe havens** like gold.
- However, markets recovered as the scope and spread of the war became clearer.

## How have markets traditionally responded to wars?

- When **Russia attacked Ukraine**, domestic stock markets crashed like ninepins.
  - Sensex tumbled 4.72%
  - NSE Nifty tanked 4.78%
- During the **Kargil war**, 1999, the Sensex gained 38% in less than three months.
- During **World War II (1939-1945)**, Dow Jones was up a total of 50%, a rise of 7% per year.

## What led to recovery this time?

- Resilience of the US economy
- Declining US bond yields
- Localised character of Israel-Hamas conflict

#### What concerns remain?

- Spread to other countries may impact **crude oil prices** impacting oil import-dependent coutries like
- If Iran, Syria or Lebanon join the conflict, will affect sea routes and push up transport and insurance costs, leading to adverse impact over India's balance of trade and CAD, thus putting pressure on the rupee.

## 2. Giant Ozone 'Hole' found over Antarctica: Reason to Worry? - Indian Express

**Relevance:** Conservation, environmental pollution and degradation, environmental impact assessment. **Context:** 

• European Space Agency Copernicus Sentinel-5P satellite detected a huge hole in the ozone layer in September, 2023, as part of the EU's environmental monitoring program.

## Prelims Takeaway

Ozone Hole / Ozone Depletion

o This year's ozone hole **started earlier than usual**, and had a big extension.

#### What Experts Say?:

- As per Experts it is not likely to increase warming of Antarctica.
- Not a concern for climate change.
- Ozone holes grow and shrink every year

#### Ozone Layer and its Significance:

- A trace gas in the stratosphere, one of the four layers of the Earth's atmosphere.
- Functions as a protective gas shield that absorbs ultraviolet radiation, protecting humans and ecosystems from dangerous amounts of UV.

#### Ozone Hole over Antarctica:

- Usual phenomena that occurs every year, opening each year in August and closing again in November or December.
- Its size over Antarctica fluctuates each year
- Reason for Formation:
  - It opens up because of the rotation of the Earth causing specials winds over the closed landmass of Antarctica.
  - o The winds create a mini climate, creating a shield over Antarctica preventing it from mixing with surrounding

### What caused the giant ozone hole this year?

- Could be due to the volcanic eruptions at Hunga Tongain Tonga during December 2022 and January 2023.
- Intensity of its eruption sent a lot of water vapor into the stratosphere which is not usual.
- Impact of Water vapor on Ozone Layer:
  - o Results in chemical reactions
  - o Change in heating rate
  - Presence of elements like bromine and iodine lead to Ozone Depletion

#### Human-caused ozone holes

- Human activities like widespread use of chlorofluorocarbons result in ozone depletion
- Use of gaseous propellants in aerosol cans which contain chlorine leading to ozone depletion.

#### **Actions Taken So Far:**

 In 1987, the Montreal Protocol was created to protect the ozone layer by phasing out the production of these harmful substances.

### Why its a Concern now?

 Extensive hole will result in longer time to repair, meaning a longer, more drawn out polar vortex, leading to longer winters.









## 3. Jobs, Still - Indian Express

**Relevance:** Population and associated issues, poverty and developmental issues **Context** 

- In recent decades the **issue of jobs** has been at the **heart of economic policy** discussion
  - The link between economic growth and employment generation has been seen to be rather tenuous.
- The **pandemic** being the **majortrigger** caused widespread **financial distress**, touching off a **surge** in **unemployment** and leading to **mass migration** back to villages

## What the Data Sayas?

- The Periodic Labour Force Survey (PLFS), (by NSSO): The unemployment rate has shown a decrease between April and June 2023.
- Labour Force Participation Rate (LFPR): Persons of age 15 years and above and the Worker-Population Ratio (WPR) have also improved during the period.
- · This indicates an improvement in the labour market.
- However, the survey also documents a decline in the share of regular wage/salaried employment and a rise in selfemployment.

#### Major outcomes of the Survey:

- The labour force participation rate (15 years and above): Increased from 49.8% in 2017-18 to 57.9% in 2022-23.
- While participation rates have increased in both rural and urban areas, the rise is to a much greater extent in the former.
- Female participation rate in rural areas has risen from 24.6 % in 2017-18 to 41.5 % in 2022-23 — an increase of roughly 17 percentage points over this period.
- Alongside this increase in labour force participation rates, the share
  of the self-employed has risen from 55.6 % in 2020-21 to 57.3 % in
  2022-23,
- While the share of regular wage/salaried employed has fallen from 21.1 % to 20.9 %.
- The percentage of workers engaged in informal sector enterprises in the non-agricultural sector has also gone up from 71.4 % in 2020-21 to 74.3 % in 2022-23.

#### Conclusion:

- While **unemployment rates** have **declined** across board, and among the youth (15-29 years),
- The **falling share** of regular **wage/salaried** and **rise** in **self-employment** reinforces **concerns** that the **economy** is **unable to generate sufficient productive** and remunerative forms of **employment** to absorb the millions entering the labour force each year.
- Inadequate job creation was, and still remains, the biggest challenge confronting policymakers.












## **Quick Look**

## 1. Retail Inflation

• India's retail inflation eased from 6.83% in August to 5.02% in September, breaking a two-month streak over the tolerance threshold of the Reserve Bank of India, with the rise in food prices easing to 6.6% from almost 10%.



## 2. World Arthritis Day

- To help spread awareness about the existence and impact of rheum atic and muskuloskeletal diseasea (RMDs), October 12 is marked as World Arthritis Day.
- Arthritis refers to joint pain or joint disease, the inflammation or swelling of one or more joints.
- As per a 2022 paper in the Osteoarthritis and Cartilage journal, 62.35 million people in India had osteoarthritis as of 2019.

## 3. ICRISAT

- It is a non-profit, non-political public international research organisation that conducts agricultural research for development in Asia & sub-Saharan Africa.
- It helps farmers by providing improved crop varieties and hybrids and also helps smallholder farmers in the drylands fight climate change.
- It conducts research on five highly nutritious drought-tolerant crops: chickpea, pigeonpea, pearl millet, sorghum, and groundnut.
- It has been awarded 2021 Africa Food Prize for the Tropical Legumes Project that has improved food security across 13 countries in sub-Saharan Africa.
- It is headquartered in Hyderabad, Telangana State, in India, with two regional hubs (Nairobi, Kenya and Bamako, Mali).

## 4. Prosopis juliflora

- It is a shrub or small tree in the family Fabaceae, a kind of mesquite.
- It is native to Mexico, South America and the Caribbean.
- It is one of the most invasive species in arid and semi-arid areas.
- It was brought to Delhi by the British in the 1920s, when the national capital was being built.
- In India it is known locally by many names such as Bellary jaali, seemai karuvelam, seemai jaali, gando baval, vilayati kikar.
- It has a very wide ecological adaptability which can grow on soils from sand dune to clay soil, and from saline to alkaline soil type.









- It can grow below 200 to above 1500 m above sea level, and with a mean annual rainfall ranging from 50 to 1500 mm
- It is considered as an Invasive plant.

## 5. Diverse Epigenetic Epidemiology Partnership (DEEP)

- It is a integrated genomics and epigenomics study to understand the genetics behind Non-Communicable Diseases (NCDs) in diverse populations
- The project is to uncover the effects of genomic and environmental diversity in disease risk observed in people across the world It is a five-year international project.
- Researchers will be studying individuals representing diverse genetic and environmental contexts and learn which DNA methylation patterns contribute to their disease risk in each context
- The study will develop software and infrastructure and conduct advanced statistical analyses to build new resources.

- RTIS devices that use satellite imagery are being installed on the trains to automatically acquire its "movement timing at the stations, including that of arrival and departure or run-through".

- These timings get automatically plotted on the control chart of those trains in the Control Office Application (COA) system.
- The project is executed by the Centre for Railway Information Systems (CRIS).
- RTIS is developed in collaboration with ISRO. ISRO has launched GSAT satellites that have GAGAN payloads for tracking the movement of trains.
- ### Applications of RTIS:
- RTIS gives mid-section updates with a periodicity of 30 seconds.
- The Train Control can now track the location and speed of RTIS-enabled locomotives/train more closely, without any manual intervention.
- It allows passengers to get the real-time location or train running status of a train on their smartphone.
